COMMISSIONERS' WORK SESSION

DISCUSSION ITEMS

1. Discussion Concerning Budget Amendments.

Pam presented the board with mid-year budget amendments. There were several departments that had unexpected expenditures that require their budgets to be adjusted. There is also a need to amend the budget for funds received from the American Rescue Plan Act. Other items are amendments for upgrades and renovations completed to buildings and structures. David also advised that an amendment to the budget policy needed to be made. He would like to make a change the date listed for the budget work session, he proposes to change that until September 21st.

2. Discussion Concerning Fire Fee.

David advised the Board that the 2nd reading will be held at the next meeting on Wednesday, September 1st. He asked the board were there any further questions or concerns regarding the fire fee ordinance or resolution. There was no further discussion by the Board.

3. Discussion Concerning Millage.

David advised the Board that there will be a public hearing and special called meeting on September 7th at 7pm for the millage. He advised that the board has discussed previously to go with a rollback of 7.809 mils. The rollback rate is possible due to the growth in the tax digest.

4. Discussion Concerning County Facilities.

David advised that he wanted to update the board on some of the renovations happening at county facilities. The DFAC and health departments has been completed for the inside. There are several items that still need to be done to the outside regarding the drainage problems and future landscaping. David also advised the Board of the work being done at the mental health building which will house the public defender's office in half of the building for now. There is painting and new flooring being completed at this time. World Finance has also requested to have a reduction in their rent at the old tax commissioner's office on Main Street. There lease agreement is not due until November so there is time for discussion at future meetings.

5. Discussion Concerning Recreation Department.

David advised that the Recreation Board is recommending for 2 field dedications once renovations are completed at the complex. They are recommending to have a football field named in honor of Carl Gunn and the softball complex named in memory of Charles Pettis. The board will discuss this at future meetings once renovations have been completed.

6. Discussion Concerning Covid Requirements.

There are several counties that are looking into adding surcharges for employees that are not getting vaccinated.
