1. Consideration to Approve Change Order for West Bypass Project.

David advised that as discussed in the previous work session, Reeves Construction is requesting a change order to include a storm drain and conduit that would allow fiber to be run from Augusta Tech to the aviation school in the future. They are wanting to move forward with this in order to keep the project moving forward. This would also allow for future growth and development at the airport. Commissioner Jopling stated that he would like to wait on the pull box and conduit until a later meeting and just move forward with the necessary storm drain for now. He would like to see if Augusta Tech would be willing to contribute to the cost of \$17,750 for the conduit addition since it will benefit them the most. David said he would reach out to the school and see what kind of response he gets.

Commissioner Jopling made the motion to approve the storm drain portion of the change order. The motion was seconded by Commissioner Thompson and passed unanimously.

2. Consideration to Approve Job Description and Authorization of Public Relations Position.

David advised that as discussed in the previous work session, Forward McDuffie, City of Dearing, City of Thomson are ready to move forward with the advertisement of the public relations position. This would be a shared position among the organizations. With the continued growth and development within the community, its going to be critical to have a PR representative moving forward.

Commissioner Thompson made the motion to approve the job description and advertisement of the Public Relations position. The motion was seconded by Vice Chairman Wilson and passed unanimously.

3. Consideration to Approve ACO Report for January 2022.

Stacey presented the January 2022 ACO Report. There was a decrease of \$12,675.05 in the property tax digest due to settled appeals in the tax assessor's office. There was also a decrease of \$349.77 to the mobile home digest from change orders from the tax assessor's office.

Commissioner Jopling made the motion to approve January 2022 ACO Report. The motion was seconded by Commissioner Thompson and passed unanimously.
